Supervisor

The Youth Guidance Counselor (also referred to as Direct Care) is responsible for providing therapeutic interactions and supervision to youth who are placed at BBH due to emotional and behavioral diagnosis. Under the supervision of the Operations Manager and Cottage Supervisor, Youth Guidance Counselors are responsible for implementing appropriate treatment strategies with the youth, timely documentation, cleaning duties, cooking duties, psycho-educational groups, and physical activities in a Trauma Informed manner.

The Youth Guidance Counselor must adhere to standards and regulations set by Birchwood Behavioral Health, State of Alaska and the Council on Accreditation. Duties are carried out in accordance with Birchwood Behavioral Health Policies and Procedures, Mission, Values, Philosophy of Care and safeguards to protect the privacy of health information in compliance with the HIPAA Privacy Rule. Youth Guidance Counselors assume additional duties as assigned and may have responsibilities altered during the course of employment.

Essential Functions of Position

- Set up the organization of the cottage routine and shall post such routine in the cottage and in the office
- Shall maintain control of the cottage within the limits of the program policy and licensing standards
- Provided safety, supervision, and monitoring of all clients
- Collect behavioral, instructional and other data as requested
- Teach clients on healthy daily living skills, coping skills and social skills
- Participate in the planning for the clients in our care
- Attend cottage staff meetings and participate as staff
- Participate in and assist the clients to participate in the life of the church and in the general spiritual growth and development
- Complete all necessary documentation as required within a timely manner
- Follow mandatory reporting laws with any and all incidents of harm within 24 hours
- Ability to assist and prepare in meals for all clients
- Work closely with the Residential Clinician, Operations Manager and Cottage Supervisor to provide quality services
- Other duties as assigned.

Position Requirements

Education/Experience: In accordance with State of Alaska residential care licensing regulation and Medicaid the Youth Guidance Counselors must be at least twenty-one years of age. It is preferred that Youth Guidance Counselors have earned a Bachelor's degree, or a combination of four years of formal education. Experience working with children may be substituted for the Bachelor's degree.

Licensure: All employees of Birchwood Behavioral Health must meet and maintain all statutory, regulatory and licensing requirements of the Department of Health and Social Services and Federal Medicaid standards. It is the responsibility of the employee to notify Birchwood Behavioral Health immediately if they no longer meet requirements. Knowledge, Skills & Abilities:

- Youth Guiidance Counselors must have the ability to relate to and experience in working with emotionally disturbed children/adolescents and their families
- Ability to work well in a team setting and communicate effectively with others
- Ability to self-regulate emotions in crisis situations and respond in a therapeutic and professional manner
- Must be able to read, write, and speak English
- Knowledge and understanding of all agency protocol, policy, procedure, plans program requirements
- Must demonstrate and display an understanding and sensitivity to serving a culturally diverse and/or special needs population
- Must possess a clean driving record and have a valid state of Alaska driver's license along with a valid certificate of insurance and auto registration.
- Must be able to pass a state and federal background check
- Must be organized, efficient, and able to multitask

Physical Requirements: Youth Guidance Counselors must be able to: drive and transport students in agency vehicles; move quickly throughout the living unit and outdoor area in order to monitor/supervise student activities, perform emergency procedures, etc. Ability to legibly produce reports regarding students and cottage events; transport self within and possible outside of the Anchorage Borough to meet with schools, families, and other involved parties; supervise and assist students with chores; operate washer and dryer, sort, fold and store laundry; participate in the maintenance of a clean living unit and grounds(shoveling/sweeping snow, raking, picking up trash, etc.); pick-up, carry and store groceries, household and program items; and supervise and participate in recreational and leisure time activities. Youth Guidance Counselors must have the ability to perform sedentary work as well as to be engaged in physical exercise with consumers such as running, walking, hiking, etc. They must demonstrate the ability to perform CPR and First Aid and other physical crisis interventions, as approved by the agency.

Working Conditions: Work is primarily performed at the Birchwood Behavioral Health, however, will include activities in the community and occasionally beyond.

Driving Requirements: Must be able to drive, have a reliable vehicle, and have a valid certificate of insurance for driving a personal vehicle for transportation between various locations within the Anchorage area. BBH employees do not transport clients in personal vehicles. This is only for one's own individual transportation.

It is our responsibility to foster an environment where trust is at the center of our decision making process.
